RESOLUTION 82-210

ACCEPTING THE BID OF N. C. MACHINERY CO. FOR THE SUPPLY OF A TRACK LOADER/FORKLIFT FOR USE AT THE HOMER BALEFILL AT A COST OF \$83,664.

WHEREAS, the Borough has solicited and opened bids for the supply of a track loader/forklift for use at the Homer Balefill; and

WHEREAS, the low bid submitted by Yukon Equipment Inc., for the supply of a track loader/forklift in the amount of \$62,146 cannot meet many of the bid specifications, most important of which are the requirements for ground bearing pressure, static tipping load, breakout force and minimum horsepower; and

WHEREAS the second low bid submitted by N.C. Machinery Co., in the amount of \$83,664 for the supply of a track loader/forklift meets all bid specifications; and

WHEREAS, the Public Works Department has recommended rejecting the bid of Yukon Equipment Inc., for the supply of a track loader/forklift as not meeting specifications; and

WHEREAS, the Public Works Department has recommended accepting the bid of N.C. Machinery Co., for the supply of a track loader/forklift; and

WHEREAS, the Assembly, by Ordinance 82-66, authorized the acceptance and appropriation of a State of Alaska, Department of Environmental Conservation (ADEC) 50% grant in the amount of \$81,692 to be used for 50% of the cost of the purchase of a track loader/forklift and a skid steer loader; and

WHEREAS, sufficient additional funding is available in the Federal Revenue Sharing accounts for the balance of the remaining 50% of their cost;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the bid of Yukon Equipment Inc., for the supply of a track loader/forklift is rejected as not meeting specifications.

Section 2. That the bid of N.C. Machinery Co., for the supply of a track loader forklift in the amount of \$83,664 is hereby accepted.

Section 3. That the ADEC grant monies in Account No. 63-27682-9110 to be used for 50% of the cost of this piece of equipment, and that the remaining 50% be appropriated from Federal Revenue Sharing monies in Account No. 06-41810-8400.

Section 4. That the Mayor is authorized to effectuate this resolution, which takes effect immediately upon its adoption.
