KENAI PENINSULA BOROUGH

RESOLUTION 82-219

CALLING AN ELECTION FOR APPROVAL OR DISAPPROVAL OF THE ESTABLISHMENT OF THE ANCHOR POINT FIRE AND EMERGENCY SERVICE AREA, AND PROVIDING FOR THE ELECTION OF A FIVE-MEMBER BOARD.

BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

1. An election is called on January 11, 1983, for the purpose of approving or disapproving the ballot proposition and for electing from the qualified voters of the Anchor Point Fire and Emergency Service Area a five-member board. The proposition to be placed on the ballot shall read:

Proposition

Do you approve establishment of the Anchor Point Fire and Emergency Service Area described as:

Beginning at the intersection of the north 1/16 line of Section 35, T5S, R15W, S.M., and the easterly mean high waterline of Cook Inlet; thence easterly, crossing the Sterling Highway at approximately Milepost 165, to the north 1/16 corner of Section 32, T5S, R14W, S.M.; thence northerly along the section line to Anchor River; thence northeasterly along the thread of Anchor River to the south fork of Anchor River; thence easterly along the south fork of Anchor River to the range line common to R11W and R12W, T4S, S.M.; thence northerly along the range line to the southwest corner of T3S, R11W, S.M.; thence westerly along the township line common to T3S and T4S, S.M., to the southwest corner of T3S, R12W, S.M.; thence northerly along the range line common to R12W and R13W, S.M., to the northeast corner of T3S, R13W, S.M.; thence westerly along the township line common to T2S and T3S, S.M., to Happy Creek; thence southwesterly along the thread of Happy Creek, crossing the Sterling Highway at approximately Milepost 144, to Cook Inlet; thence westerly across Cook Inlet to the intersection of the township line common to T2S and T3S, S.M., and the mean high water line of the westerly shore of Cook Inlet; thence southwesterly along the mean high water line of Cook Inlet to the intersection of the township line common to T5S and T6S, S.M., near Chinitna Point; thence easterly across Cook Inlet to the north 1/16 line of Section 35, T5S, R15W, S.M., and the easterly mean high water line of Cook Inlet, the true point of beginning, for the purpose of providing

fire protection services to the residents of the Anchor Point Fire and Emergency Service Area with a mill rate not to exceed 2 mills.

2. At the same election there shall be elected a five-member Board of Directors to serve in the event the service area is approved, and for the purpose of such election, candidates shall file for specific seats designated A, B, C, D, and E, and the terms for each of such seats shall be as follows:

A - Three years

B - Three years

C - Two years for the initial term, and three years for subsequent terms

D - Two years for the initial term, and three years for subsequent terms

E - One year for the initial term, and three years for subsequent terms

3. A candidate for any office specified in this notice must be a qualified voter of the Anchor Point Fire and Emergency Service Area. Nomination by petition signed by ten qualified voters of the Anchor Point Fire and Emergency Service Area is required to qualify a person as a candidate whose name is to be listed on the ballot. Nomination petitions may be filed with the Borough Clerk at the Borough office, Soldotna, Alaska, until 4:00 p.m., December 17, 1982. Petitions must be received in the Borough office prior to the time and date specified in order to be valid. A person named in the nomination petition must sign thereon the following statement: "I hereby accept the above nomination and agree to serve if elected." This statement is a part of the nomination petition. Nomination petition forms may be obtained from the Borough Clerk's office by request in person or by mail.

4. Any person is qualified to vote who: Is a citizen of the United States who is qualified to vote in state elections, has been a resident of that portion of the Kenai Peninsula Borough included within the Anchor Point Fire and Emergency Service Area for at least 30 days immediately preceding the election, and is registered with the State of Alaska as a voter in the precinct in which he resides.

5. The polling place is established at the Anchor Point Community Hall.

6. Polls will be open from 8 a.m. until 8 p.m.

7. A qualified voter may vote by absentee ballot in accordance with state law.
