## RESOLUTION 82-23

RECOMMENDING THAT THE TWELFTH ALASKA LEGISLATURE, SECOND SESSION, MAKE A SPECIAL APPROPRIATION OR GRANT FOR THE PURCHASE OF FIRE FIGHTING EQUIPMENT AND CONSTRUCTION OF FIRE FIGHTING FACILITIES FOR THE BEAR CREEK FIRE SERVICE AREA.

WHEREAS, the Twelfth Alaska Legislature, Second Session, is presently convened and will be considering legislation which makes special appropriations for the purchase of fire fighting equipment and construction of fire fighting facilities; and

WHEREAS, the Bear Creek Fire Service Area Board has adopted a resolution requesting an appropriation or grant through the State of alaska for needed fire fighting equipment; and

WHEREAS, the Assembly approves the State of Alaska's program of grants to assist fire fighting agencies in the protection of life and property;

WHEREAS, the Southern Regional Emergency Medical Services Council has approved and recommended an appropriation in the state budget of \$30,000 for a crash rescue vehicle for the Bear Creek Volunteer Fire Department.

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. That the Assembly requests a special appropriation or grant of \$70,000 to the Bear Creek Fire Service Area for the purchase of two (2) fire tankers.
- Section 2. That the Assembly approves of the acquisition of a crash rescue vehicle and requests the state legislature to approve a \$30,000 budget item for this purchase by the Bear Creek Volunteer Fire Department.
- Section 3. That the Clerk shall serve a copy of this resolution upon the Honorable Jay S. Hammond, Governor of the State of Alaska; upon the Honorable Jalmar Kerttula, President
