RESOLUTION 83-113

AMENDING THE ALLOCATION OF MUNICIPAL AID GRANT FUNDS PROVIDED IN RESOLUTION 82-187 BY TRANSFERRING \$12,885 FROM HOPE LANDFILL DEVELOPMENT TO THE TRANSFER BOX CONSTRUCTION PROJECT.

WHEREAS, the Assembly by Resolution 82-187 has allocated municipal aid grant funds received from the State of Alaska; and

WHEREAS, the transfer boxes have proven beneficial to the solid waste program; and

WHEREAS, three additional transfer boxes were constructed to enhance the solid waste program; and

WHEREAS, these three boxes cost an amount of \$12,885;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That \$12,885 be transferred from the Hope Landfill Development Project Account No. 65-27781-9007 to the Transfer Box Construction Project Account No. 65-29681-9110.

Section 2. That expenditures for all projects shall read as follows:
