RESOLUTION 83-169

AMENDING THE ALLOCATION OF MUNICIPAL AID GRANT FUNDS PROVIDED IN RESOLUTION 83-155 BY TRANSFERRING \$200,000 FROM STERLING SPECIAL WASTE SITE RELOCATION, SELDOVIA LANDFILL ACCESS ROAD, NORTH ANCHOR RIVER ROAD, SKYLINE DRIVE, SPORT LAKE ROAD, BIG EDDY ROAD, ENGLISH BAY LANDFILL IMPROVEMENTS AND TYONEK LANDFILL IMPROVEMENTS PROJECTS TO THE RESURRECTION RIVER ROAD PROJECT.

WHEREAS, the Assembly by Resolution 83-155 has allocated Municipal Aid Grant Funds received from the State of Alaska; and

WHEREAS, Resurrection River Road is a priority project; and

WHEREAS, surplus funds exist in the Sterling Special Waste Site Relocation, Seldovia Landfill Access Road, North Anchor River Road, Skyline Drive, Sport Lake Road, Big Eddy Road, English Bay Landfill Improvements and Tyonek Landfill Improvements Projects for the Resurrection River Road Project.

NOW THEREFORE BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


