*NEGOTIATE*

A RESOLUTION REQUESTING THE MAYOR OF THE KENAI PENINSULA BOROUGH TO ~~ACCEPT THE MARRIAGE ROAD PROPOSAL~~ FOR THE HALBOUTY ROAD RIGHT-OF-WAY, TO OFFER ETHEL D. HENDERSON \$6,000 PER ACRE FOR THE LAND NEEDED FOR RIGHT-OF-WAY FOR HALBOUTY ROAD ACROSS HER PROPERTY, AND TO DRAFT A RESOLUTION RESTORING FUNDS TO THE HALBOUTY ROAD PROJECT.

WHEREAS, completion of the Halbouty Road Project should not be unduly delayed; and

*DELETE* WHEREAS, 63 residents of the Halbouty Road area have signed the petition requesting the Borough to pay Ethel D. Henderson up to \$6,000 per acre for land necessary for right-of-way for said Halbouty Road; and

WHEREAS, Ethel D. Henderson has reported that an appraisal ordered by her has set the value of that property at \$4,500 per acre and that she has had other expenses connected with the project such as legal fees and appraisal fee; and

WHEREAS, under the provisions of AS 29.23.140, it is the responsibility of the Borough Mayor to execute the budget and capital improvement program as adopted and to direct and supervise the administration of the construction, maintenance, and operation of all Borough roads, bridges, drains, buildings, and other public works;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

*AMEND* { Section 1. That in order to expedite the continuation and completion of the Halbouty Road Project, the Mayor of the Kenai Peninsula Borough is hereby requested to accept the Marriage Road alignment requested by Ethel D. Henderson in accordance with her letter of December 7, 1982.

*DELETE* Section 2. That the Mayor is further requested to make an offer to Ethel D. Henderson of up to \$6,000 per acre for the land to be taken from her for right-of-way for the Halbouty Road Project.

*DELETE* Section 3. That the Mayor is further requested to draft a resolution restoring to the Halbouty Road Project sufficient

~~funds to accomplish the purposes of this resolution and to complete the project.~~
