KENAI PENINSULA BOROUGH

RESOLUTION 84-96

PROVIDING FOR EXECUTIVE AND ADMINISTRATIVE SALARY ASSIGNMENTS FOR BOROUGH STAFF DEPARTMENT HEADS AND OTHER EXEMPT PERSONNEL.

WHEREAS, the Assembly has delegated to the Mayor the authority to establish administrative and executive salaries; and

WHEREAS, there have been only three general staff base salary adjustments since July, 1977;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That staff department heads will receive an annual salary not to exceed the following amounts;
