## RESOLUTION 85-4 (AMENDED)

ESTABLISHING GUIDELINES TO BE USED IN ALLOCATING FEDERAL REVENUE SHARING FUNDS TO SENIOR CITIZENS ORGANIZATIONS.

WHEREAS, the Assembly has in the past appropriated funds for use by senior citizens organizations within the Borough; and

WHEREAS, this appropriation has come from Federal Revenue Sharing funds; and

WHEREAS, the recent census conducted within the Borough has provided information as to populations of senior citizens served by the various organizations; and

WHEREAS, the Assembly wishes to establish guidelines to use in allocating senior citizens funds; and

WHEREAS, these guidelines should include per capita funding based upon number of senior citizens groups being formed that meet the required criteria and to also provide for start-up funds for new senior citizens organizations;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. That the Borough Assembly will utilize the guidelines established by this resolution in determining the allocation of Federal Revenue Sharing funds available for senior citizens organizations.
- Section 2. That for the purposes of this resolution, the criteria for establishing an organization or group are: the group must be non-profit, tax exempt, or be sponsored by a city. Senior citizens served must be sixty (60) years of age or older, or the spouse of a senior citizen.
- Section 3. That for each senior citizens organization or group established within the fiscal year of the Borough immediately preceding the fiscal year for which the appropriation is to be made, the Borough Assembly may provide for a one time start-up grant of \$5,000 before allocating the available funds to individual organizations or groups.
- Section 4. That after start-up funds have been provided, the remaining available funds will be allocated in proportion to the number of persons within each organization or group to the total number of persons served by all organizations or groups requesting such funds.

Section 5. That for purposes of allocations made under this resolution the number of persons within each organization are established as:

Section 6. That other organizations or groups meeting the required criteria may request funding. The per capita of any new group will be determined by the Assembly and funds will be allocated in accordance with this resolution.

Section 7. That this resolution does not establish any obligation to provide certain levels of funding and such funding, if any, and its allocation are solely the determination of the Borough Assembly.
