RESOLUTION 85-195

AMENDING THE ALLOCATION OF GRANT FUNDS PROVIDED IN RESOLUTION 85-36 BY TRANSFERRING \$30,000 FROM VARIOUS ACCOUNTS TO EAST END ROAD.

WHEREAS, the Assembly by Resolution 85-36 has allocated funds from Grant 8-284 in accordance with legislative intent; and

WHEREAS, the legislative intent by Senator Gilman's letter dated November 30, 1981, allows for the transfer of surplus funds to other road design projects so designated by the Borough Assembly; and

WHEREAS, the correction of a sight distance problem at the intersection of Fairview Avenue and East End Road is a high priority; and

WHEREAS, the design of Anchor River and Lamplight Road are complete and surplus funds exists in the amount of \$12,691.50 and \$1,355.40 in these road accounts respectively; and

WHEREAS, excess design funds exist in the Skyline Drive and Ciechanski Road accounts in the amount of \$7,976.55 each respectively;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That \$30,000 shall be allocated to the East End Road Account 416-331012-49999-81739 from the following accounts:


