## RESOLUTION 85-59

DESIGNATING THE NEWSPAPER AND AWARDING THE CONTRACT FOR THE PUBLICATION OF THE PROPERTY TAX FORECLOSURE LIST FOR THE TAX YEAR 1984 AND THE DELINQUENT PERSONAL PROPERTY TAX LIST.

WHEREAS, the Borough is required by statute to publish an annual foreclosure list setting forth the names and amounts of all delinquent real property taxes; and

WHEREAS, the Borough will publish a list of the names and addresses of all persons having delinquent personal property taxes; and

WHEREAS, the Borough has opened bids for the performance of all work required to print, publish, and distribute the 1984 property tax foreclosure list and the delinquent personal property tax list; and

WHEREAS, the Finance Department estimates that the contractor will be required to publish approximately 200 computer pages for the 1984 tax foreclosure list and approximately 200 computer pages for the personal property delinquency list; and

WHEREAS, the Finance Department has evaluated the bids and recommends an award of the contract; and

WHEREAS, the Assembly is required to designate the newspaper which will publish the foreclosure list and delinquency list;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the bid of the Peninsula Clarion to perform all work necessary to print, publish, and distribute the foreclosure list for the 1984 tax year for a unit price of \$69.73 per page of computer printout and the delinquent personal property tax list for a unit price of \$13.41 per page of computer printout is accepted, and a contract for this work is awarded to this designated newspaper. The publication shall begin with the week of April 22, 1985. The foreclosure list will be published for four (4) consecutive weeks, and the delinquent personal property list will be run for one (1) week. The total contract price shall be determined by multiplying the number of computer printout pages which the contractor must publish by the bid price per page. All expenditures for this contract shall be charged to Account No. 100.113010.43310.

 $\underline{\text{Section 2}}.$  That the contract will be adjusted by any increase in postal rates that may take effect prior to the final publication date.

 $\frac{\text{Section 3}}{\text{its adoption}}$ . That this resolution takes effect immediately upon its adoption.
