KENAI PENINSULA BOROUGH

RESOLUTION 86-18

RELINQUISHING CERTAIN APPROVED LANDS SELECTED BY THE BOROUGH FROM THE STATE OF ALASKA PURSUANT TO THE MUNICIPAL ENTITLEMENT ACT.

WHEREAS, the Borough selected certain lands in the Fritz Creek area near Homer as part of its municipal entitlement; and

WHEREAS, the State legislature created the Anchor River-Fritz Creek Critical Habitat Area which includes these approved selections; and

WHEREAS, conveyance of these selections to the Borough by the State of Alaska would be subject to the provisions of the Anchor River-Fritz Creek Critical Habitat Area; and

WHEREAS, the Planning Commission reviewed these lands and recommended relinquishment at its January 20, 1986 meeting;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


Section 2. That the Mayor is authorized to sign any and all documents necessary to effectuate this resolution and deemed to be in the best interest of the Borough.
