RESOLUTION 86-23

AMENDING THE ALLOCATION OF MUNICIPAL AID GRANT FUNDS PROVIDED IN RESOLUTION 85-91 BY TRANSFERRING FROM VARIOUS PROJECTS \$42,211.44 TO COHOE LOOP ROAD.

WHEREAS, the Assembly by Resolution 85-91 has allocated Municipal Aid grant funds received from the State of Alaska; and

WHEREAS, additional funds are necessary to establish an adequate budget for the paving of Cohoe Loop Road; and

WHEREAS, excess funds exist in the Anchor River, Bean Creek and Sport Lake projects;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That \$42,211.44 be allocated to the Cohoe Loop Road account 415-331026-49999-81718 from the following accounts:
