RESOLUTION 86-77

PROVIDING FOR BROADCASTING OF REGULAR AND SPECIAL ASSEMBLY MEET-INGS AND AWARDING CONTRACTS TO RADIO STATIONS KSRM, KGTL, AND KRXA FOR FISCAL YEAR 1986-87 TO PROVIDE BROADCASTING.

WHEREAS, it is desirable that the citizens of the Borough be as fully informed as possible regarding matters brought before the assembly; and

WHEREAS, the most effective method of informing the citizens of the Borough is through the live broadcastings of all regular and special Borough assembly meetings; and

WHEREAS, proposals have been requested and received from radio stations throughout the Borough to provide broadcasting of all regular and special meetings for fiscal year 1986-87; and

WHEREAS, Radio Station KSRM submitted the only bid to provide broadcasting direct from the assembly room and to provide a feed to participating stations; and

WHEREAS, Radio Station KGTL in Homer and Radio Station KRXA in Seward submitted bids to provide assembly broadcasting to the Homer and Seward areas respectively;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the Mayor is authorized to contract with Radio Station KSRM to provide broadcasting or regular and special assembly meetings for a price of \$485.00 per meeting. KSRM is to provide an announcer, broadcast equipment, engineering, line set-up charges, air time, and all other equipment and personnel as needed to provide live coverage of each assembly meeting, and to provide audio feed to any other station specified by the assembly to receive programming. Actual charges for phone or long distance calls needed to feed participating stations will be billed directly to the Borough.

 $\underline{\text{Section 2}}$. That the Mayor is authorized to contract with Radio Station KGTL to receive a feed of assembly meetings from Radio Station KSRM and provide broadcasting of regular and special assembly meetings for a price of \$315.00 per meeting plus \$75.00 per hour for broadcast coverage after 12 midnight.

 $\underline{\text{Section 3}}$. That the Mayor is authorized to contract with Radio Station KRXA to receive a feed of assembly meetings from Radio Station KSRM and provide broadcasting of regular and

special assembly meetings for a price of \$300.00 per meeting plus \$50.00 per hour for broadcast coverage after 12 midnight.

Section 4. That broadcasting under these contracts will begin with the first regularly scheduled meeting in July, 1986.

 $\underline{\underline{Section\ 5}}.$ That this resolution takes effect immediately upon its adoption.
