OPPOSING PASSAGE OF HOUSE BILL 274 WHICH WOULD INCLUDE THE UNDEFINED TERM "MENTAL INJURY" WITHIN THE DEFINITION OF CHILD ABUSE UNDER ALASKA STATUTES.

WHEREAS, HB 274 currently pending in the legislature would add "mental injury" to the definition of child abuse; and

WHEREAS, there are no definition of mental injury included in the legislation and its meaning is entirely subjective and vague;

WHEREAS, this country was founded upon the principal that subjective interpretation and application of laws was wrong; and

WHEREAS, the term "mental injury" can be capable of such application unless clearly defined;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

<u>Section 1</u>. That the assembly opposes the passage of HB 274 which would include the term "mental injury" within the definition of child abuse under the Alaska Statutes for the reason that the term is undefined and is vague and capable of over-broad application. The use of vague language which can be subjectively applied should be discouraged.

Section 2. That copies of this resolution shall be sent to Governor Steve Cowper; Senators John Binkley, Paul Fischer, Jalmar Kerttula and Mike Szymanski; and Representatives Bette Cato, Mike Navarre, C.E. Swackhammer, Kay Wallis and Jim Zawacki.
