KENAI PENINSULA BOROUGH

RESOLUTION 87-72

PROVIDING FOR THE SELECTION OF CERTAIN LANDS LOCATED IN THE HOPE/SUNRISE AREA FOR CONVEYANCE FROM THE STATE OF ALASKA TO THE KENAI PENINSULA BOROUGH.

WHEREAS, the Borough may select lands from the State of Alaska pursuant to the Municipal Entitlement Act; and,

WHEREAS, these certain lands were nominated for selection by the Borough pursuant to KPB Resolution 78-124 dated December, 1978; and,

WHEREAS, the Hope/Sunrise Advisory Planning Commission reviewed previously selected lands and these nominated lands; and,

WHEREAS, the KPB Planning Commission reviewed this selection of lands at its July 27, 1987 meeting;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:




