KENAI PENINSULA BOROUGH

RESOLUTION 87-73

PROVIDING FOR THE SELECTION OF CERTAIN LANDS LOCATED IN THE MOOSE PASS AREA FOR CONVEYANCE FROM THE STATE OF ALASKA TO THE KENAI PENINSULA BOROUGH.

WHEREAS, the Borough may select lands from the State of Alaska pursuant to the Municipal Entitlement Act; and,

WHEREAS, certain lands were nominated for selection by the Borough pursuant to KPB Resolution 78-124 dated December 5, 1978; and,


