RESOLUTION 87-74

PROVIDING FOR THE SELECTION OF CERTAIN LANDS LOCATED IN THE COOPER LANDING AREA FOR CONVEYANCE FROM THE STATE OF ALASKA TO THE KENAI PENINSULA BOROUGH.

WHEREAS, the Borough may select lands from the State of Alaska pursuant to the Municipal Entitlement Act; and

WHEREAS, these certain lands were nominated for selection by the Borough pursuant to KPB Resolution 78-124 dated December 5, 1978; and

WHEREAS, the KPB Planning Commission reviewed this selection of lands at its August 19, 1987 meeting;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


