RESOLUTION 87-77

PROVIDING FOR THE SELECTION OF CERTAIN LANDS LOCATED IN THE SEWARD AREA FOR CONVEYANCE FROM THE STATE OF ALASKA TO THE KENAI PENINSULA BOROUGH.


