NOW THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH  
DECLARES:

Section 1. That in the Boroughwide election for Borough  
Mayor, Donald E. Gilman was elected by 60 percent of the vote.

Section 2. That in the Boroughwide election for three  
Board of Education members, Marilyn Dimmick, Cliff Massie and  
Michael Wiley were elected with the three highest vote tallies  
and in excess of 40 percent of the vote.

Section 3. That in Assembly District 1, Seat A, James W.  
Skogstad was elected to a three year term.

Section 4. That in Assembly District 2, Seat A, Sharon  
Mooch was elected to a three year term and in Seat E, Frank  
Mullen was elected to a three year term.

Section 5. That in Assembly District 3, Seat B, Jack Brown  
was elected to a three year term and in Seat C, Mark Hodgins was  
elected to a three year term.

Section 6. That in Assembly District 4, Seat A, John  
Crawford was elected to a three year term and in Seat C, Gail  
Phillips was elected to a one year term.

Section 7. That in the Anchor Point Fire and Emergency  
Service Area there was no candidate for Seat E and Mary Shannon  
was elected by write-in vote to a three year term.

Section 8. That in the Bear Creek Fire Service Area there  
was no candidate for Seat E and Eric Traber was elected to a  
three year term by write-in vote.

Section 9. That in the East Road Maintenance Service Area there was no candidate for Seat A and Ken Baysinger was elected to a three year term by write-in vote. There was no candidate for Seat B and Mitch Johnson, Robert Leary and Eric Traber received an equal number of write-in votes for a three year term. There was no candidate for Seat C, a two year term and Larry Smith was elected by write-in vote.

Section 10. That in the Central Peninsula Emergency Medical Service Area, Kenneth H. Hepner was elected to Seat A, a three year term and Millie FitzGerald was elected to Seat B, a three year term.

Section 11. That in the Central Peninsula Road Maintenance Service Area Ray Posey was elected to Seat A, a three year term and Robert H. (Bob) Pope was elected to Seat B, a three year term.

Section 12. That in the Kalifornsky Fire Service Area Randy Willis was elected to Seat C, a three year term and David Donald was elected to Seat D, a three year term.

Section 13. That Nikiski Fire Service Area Preston Williams was elected to Seat D, a one year term, Gene Browning was elected to Seat F, a three year term, and Sandra J. Traxinger was elected to Seat G, a three year term.

Section 14. That in the North Peninsula Recreation Service Area, Fred Rector was elected to Seat E, a three year term.

Section 15. That in the North Peninsula Road Maintenance Service Area James J. Goff was elected to Seat A, a three year term and William F. McGahan was elected to Seat B, a three year term.

Section 16. That in the Ridgeway-Sterling Fire Service Area Ken Brown was elected to Seat B, a two year term, Glenn D. Schrader was elected to Seat C, a three year term and Hugh Chumley was elected to Seat D, a three year term.

Section 17. That in the South Peninsula Hospital Service Area Howard Myhill was elected to Seat D, a three year term, Leroy Gannaway was elected to Seat E, a three year term and Johnnie Parks was elected to Seat F, a three year term.

Section 18. That in the South Peninsula Road Maintenance Service Area David M. Bear was elected to Seat A, a three year term and Marilyn Dimmick was elected to Seat B, a three year term.

Section 19. That this resolution takes effect immediately upon its adoption.
