NOW THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH  
DECLARES:

Section 1. That in the boroughwide election for two Board of Education members, Joyce Fischer and Wayne Kessler were elected having received the highest vote tallies of five candidates and in excess of 40 percent of the vote.

Section 2. That in the boroughwide election the Proposition approving construction of a new elementary school in Seward, Alaska was approved by the voters.

Section 3. That in Assembly District 2, Stan A. "Sam" McLane was elected to a second 3 year term in Seat B.

Section 4. That in Assembly District 3, Betty J. Glick was elected to a third 3 year term in Seat E.

Section 5. That in Assembly District 4, Brentley D. Keene was elected to a third 3 year term in Seat B, and Charles "Al" Poindexter was elected to a 3 year term in Seat C.

Section 6. That in the Bear Creek Fire Service Area, Clara M. Fultz was elected to a second 3 year term in Seat C, and Dewey J. Smith was elected to a three year term in Seat D.

Section 7. That in the East Kenai Peninsula Road Maintenance Service Area, no one filed for the vacancies, Seat C, one year term and Seat E, three year term. For Seat C, Rick Jones received the most write-in votes and was elected to a one year term. For Seat E, Ken Baysinger received the most votes but currently serves the board in Seat A. Two write-ins tied for the second highest tally, Rick Jones, clearly elected to Seat C, and Karen Skogstad who was therefore elected to Seat E for a three year term.

Section 8. That in the Central Peninsula Emergency Medical Service Area, Emery Thibodeau was elected to a three year term in Seat E.

Section 9. That in the Central Kenai Peninsula Road Maintenance Service Area John E. Cook was elected to a three year term in Seat E.

Section 10. That in the Kalifornsky Fire Service Area, John Fairchild was elected to a three year term in Seat A, Emery Thibodeau was elected to a three year term in Seat B.

Section 11. That in the Ridgeway/Sterling Fire Service Area, Darlene M. Wilder was elected to a three year term in Seat E.

Section 12. That in the Nikiski Fire Service Area Mae M. Leighton was elected to a one year term in Seat A, write-in Preston Williams was elected to both Seat C and Seat D with no other write-ins receiving more than one vote each, and Scott B. Hagen was elected to Seat E, a three year term.

Section 13. That in the North Peninsula Recreation Service Area Audrey Hodgins was elected to a second three year term in Seat C and write-in Ron Johnson was elected to a three year term in Seat D.

Section 14. That in the North Kenai Peninsula Road Maintenance Service Area, Sharon M. Brower was elected to a one year term in Seat C and Ron Johnson was elected to a three year term in Seat E.

Section 15. That in the Anchor Point Fire and Emergency Service Area, Clifford A. Shafer was elected to a one year term in Seat B, William L. Donner was elected to a three year term in Seat C and James Pastro was elected to a three year term in Seat D.

Section 16. That in the South Peninsula Hospital Service Area, Enid M. Jones was elected to a three year term in Seat A, Robert Paul Purcell was elected to a three year term in Seat B and Gary R. Thomas was elected to a three year term in Seat C.

Section 17. That in the South Kenai Peninsula Road Maintenance Service Area Willy Nye was elected to a three year term in Seat E.
