WHEREAS, the legislative sessions would be more accessible to the majority of the population if held in the most populated regions of the state, and

WHEREAS, housing in Juneau is becoming increasingly difficult to obtain during the short legislative session, and

WHEREAS, the existing communications systems would allow legislators to maintain contact with government offices while meeting in locations other than Juneau, and

WHEREAS, state buildings and infrastructure exist in Anchorage and Fairbanks; and

WHEREAS, considerable expense and travel delays cause economic difficulties for concerned citizens; and

WHEREAS, a greater portion of the public would be able to become directly involved with their legislative process.

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

<u>Section 1</u>. The Kenai Peninsula Borough Assembly would request the legislature to consider convening sessions in Anchorage and Fairbanks on alternate years.

<u>Section 2</u>. Copies be sent to the Legislature, Governor and borough assemblies throughout the state.
