- Section 2:** That in Assembly District 2, Seat B, no candidate was elected having not received forty (40%) percent of the vote.
- Section 3:** That in Assembly District 2, Seat C, Grace Merkes was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- Section 4:** That in Assembly District 2, Seat D, John Torgerson was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- Section 5:** That in Assembly District 3, Seat E, Betty Glick was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- Section 6:** That in Assembly District 4, Seat B, H. V. Kyllonen was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- Section 7:** That in Assembly District 4, Seat C, John Calhoun was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.


- Section 8:** That in the areawide vote, Proposition #1 approving a plan for reapportionment of the assembly, Plan 2 was approved by the voters areawide.
- Section 9:** That in the non-areawide vote, Proposition #2, providing for non-areawide authority of the Kenai Peninsula Borough to provide for utility lines or extensions in the area outside cities through the formation of special assessment districts for repayment of costs by the benefitted property owners, was approved by the voters outside the cities.
- Section 10:** That in the Anchor Point Fire and Emergency Service Area, Seat A, Joe Tracy was elected to a 1 year term; Seat C, Jim Pastro was elected to a 3 year term; and, Seat D, Robert Craig was elected to a 3 year term.
- Section 11:** That in the Bear Creek Fire Service Area, Seat C, Sam Daniel was elected to a 3 year term, and Seat D, Dewey Smith was elected to a 3 year term.
- Section 12:** That in the Central Peninsula Emergency Medical Service Area, Seat A, Thomas Hodel was elected to a 2 year term, and Seat E, Dave Carey was elected to a 3 year term.
- Section 13:** That in the new Central Peninsula Emergency Medical Service Area vote, Proposition #3 approving the exercise of fire and emergency medical service powers within the new "Central Emergency Service Area", which will consolidate the emergency services operations of the Kalifornsky Fire Service Area, the Ridgeway/Sterling Fire Service Area, the City of Soldotna, and portions of the Central Peninsula Emergency Medical Service Area, was approved by the voters of the new Central Peninsula Emergency Medical Service Area.
- Section 14:** That in the Kalifonsky Fire Service Area, Seat A, Martin Hall was elected to a 3 year term, Seat B, Ted Titus was elected to a 3 year term, and Seat C, Stan "Sam" McLane was elected to a 2 year term.
- Section 15:** That in the Nikiski Fire Service Area, Seat C, Steve Hoogland was elected to a 1 year term, Seat E, Fred Newton was elected to a 3 year term, and Seat D, Preston Williams was elected to a 1 year term.
- Section 16:** That in the North Peninsula Recreation Service Area, Seat C, Audrey Hodgins was elected for a 3 year term, and, Seat D, Marion Nelson was elected to a 3 year term.
- Section 17:** That in the Ridgeway/Sterling Fire Service Area, Seat E, Gordon Arteno was elected to a 1 year term.
- Section 18:** That in the South Peninsula Hospital Service Area, Seat A, Charles Davis, Jr. was elected to a 3 year term, Seat B, Vickey Hodnik was elected to a 3 year

term, Seat C, Gary Van Oskolkoff was elected to a 3 year term, and Seat H, Gary Thomas was elected to a 1 year term.


