A RESOLUTION CLASSIFYING APPROXIMATELY 2,214 ACRES OF BOROUGH LANDS IN THE VICINITY OF SUNRISE, ALASKA PURSUANT TO KPB 17.10.080

- WHEREAS, the Borough has received a final decision from the State of Alaska for the lands to be classified; and
- WHEREAS, KPB Ordinance 93-35 adopted the 1988 Sunrise Community Land Use Plan and the July 1992 additions as elements of the Borough's Comprehensive Plan; and
- WHEREAS, in accordance with Chapter 17.10.080 public notice has been published and notification has been sent to land owners and/or leaseholders of record within one-half mile of the area to be classified, to applicable agencies and interested parties; and
- WHEREAS, the Kenai Peninsula Borough Planning Commission held a public meeting on the classification at its meeting of February 27, 1995 and recommended adoption of the resolution by unanimous consent; and
- WHEREAS, the Hope/Sunrise Advisory Planning Commission held a public meeting on the proposed classifications April 1, 1995 and recommended adoption by unanimous consent;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That those Borough lands lying within portions of Sections 2, 3, 10, 11, 14, 15 & 22 Township 9 North, Range 1 West, S.M., Alaska and Sections 33, 34 & 35 Township 10 North, Range 1 West, S.M., Alaska, and shown on the map marked "Attachment A" are classified as follows:
