A RESOLUTION CLASSIFYING BOROUGH LAND IN THE AREA OF SKYVIEW HIGH SCHOOL AND THE SOLDOTNA LANDFILL

- WHEREAS, the Borough has received State patents and deeds to the lands being classified; and
- WHEREAS, the Kenai Peninsula Borough Solid Waste Department supports the waste handling classification for the existing and projected expansion of the Soldotna Landfill site; and
- WHEREAS, the School Site Selection Committee and the Kenai Peninsula School Board have recommended two potential sites be retained and classified for a future middle school; and
- WHEREAS, the Kenai Peninsula Aerobic Sports Association currently holds a permit for the operation of the Tsalteshi community trails; and
- WHEREAS, the Department of Transportation and Public Facilities has identified a site for the future State Department of Transportation maintenance facility site; and
- WHEREAS, in accordance with Chapter 17.10.080 public notice has been published and notification has been sent to land owners and/or leaseholders of record within one-half mile of the area to be classified, and to applicable agencies and interested parties; and
- WHEREAS, the Planning Commission held a public hearing on the proposed classification June 26, 1995 and recommended adoption by unanimous consent;

NOW, THEREFORE, BE IT RESOLVED BY THE KENAI PENINSULA BOROUGH ASSEMBLY THAT:

SECTION 1. Those borough lands located within the T4N, R11W, S.M., Alaska are classified as:

GOVERNMENT (containing approximately 634 acres)

Section 1: E½ except the north 535 feet. Also except City of Soldotna Reservoir

& Tract A.

Section 12: NE¼, N½SE¼ except City of Soldotna property, NW¼SW¼,

S½SW¼ except Sterling Forest Subdivision

Section 13: NW¼, N½SW¼, SW¼SW¼

Section 14: N½NE¼, SE¼NE¼, E½SW¼NE¼

COMMERCIAL (containing approximately 27.26 acres)

Section 1: The north 535 feet of the NE¼ except Kalifornsky Beach Road

WASTE HANDLING (containing approximately 235 acres)

Section 12: S½SE¼ lying east of the Sterling Highway R.O.W.

Section 13: NE1/4
