NOW, THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH DECLARES:

- SECTION 1.** That in the Borough-wide election for School Board, Seat F, Deborah Germano was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote; and, Seat G, no candidate was elected having not received forty (40%) percent of the vote.
- SECTION 2.** That in Assembly District 3, Jack Brown was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 3.** That in Assembly District 4, Dale Bagley was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 4.** That in Assembly District 7, Debra Horn was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 5.** That in the Anchor Point Fire and Emergency Service Area, Seat B, Joe Tracy, was


elected to a 3-year term.

- SECTION 6.** That in the Bear Creek Fire Service Area, Seat A, Seat B, and Seat C, no candidates were elected.
- SECTION 7.** That for the Joint Operations Board for the Central Peninsula Emergency Medical Services and the Central Emergency Services Service Areas, Seat A, Ken Hepner, and Seat B, David Stousland, were elected to 3-year terms.
- SECTION 8.** That in the Nikiski Fire Service Area, Seat A, Mae Leighton, Seat B, Jack Focose, and, Seat C, Steve Hoogland were elected to 3-year terms.
- SECTION 10.** That in the Nikiski Senior Service Area, Seat B, Richard Gunter was elected by write-in votes to a 3-year term; and, Seat C, Rosi Johnson was elected to a 3-year term.
- SECTION 11.** That in the North Peninsula Recreation Service Area, Seat A, Marian Nickelson, and, Seat B, Richard Dority, were elected for a 3-year terms.
- SECTION 12.** That in the South Peninsula Hospital Service Area, Seat G, Thomas Schoder, Seat H, Brenda Steenblock, and, Seat I, Frances Brymer were elected to 3-year terms.
