RESOLUTION 96-043**

**A RESOLUTION AUTHORIZING AWARD OF CONTRACTS FOR ROOFING AT  
KENAI CENTRAL HIGH VOCATIONAL BUILDING, KENAI MIDDLE SCHOOL,  
HOMER MIDDLE SCHOOL, AND SEWARD HIGH**

**WHEREAS,** the Maintenance Department has formally solicited and received bids for these projects; and

**WHEREAS,** the low bids submitted for each project are fair and reasonable and the bidders are qualified to perform the work; and

**WHEREAS,** funds were appropriated to the FY 95/96 capital projects budget for these projects from legislative grants and the general fund;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the Mayor is authorized to award a contract to Peninsula Roofing in the amount of \$61,527.00 for the roofing project at Kenai Central High Vocational Building, and in the amount of \$348,881.00 for the roofing project at Kenai Middle School.

**SECTION 2.** That the Mayor is authorized to award a contract to Industrial Roofing, Inc. in the amount of \$192,000.00 for the roofing project at Homer Middle School, in the amount of \$173,600.00 for the roofing project at Seward High, and in the amount of \$78,100.00 for the Additive Alternate roofing project at Seward High.

**SECTION 3.** That expenditures for the Kenai Central High Vocational Building will be charged to account numbers 400.730201.49999.96736 and 241.410010.49128.96736; Kenai Middle School will be charged to account numbers 400.730300.49999.96737 and 241.410010.49128.96737; Homer Middle School will be charged to account numbers 400.720300.49999.96782 and 241.410010.49128.96782; and Seward High will be charged to account numbers 400.750200.49999.96780, 400.750200.49999.96744, 400.750200.49999.96003, and 241.410010.49128.96780.


**SECTION 4.** That the Mayor is authorized to execute all documents and make all agreements deemed necessary to complete these projects in accordance with this resolution and the contract documents.
