NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


SECTION 1. That in the Borough-wide election for Assembly District 1, William Popp was elected having received the highest vote tallies.
