KENAI PENINSULA BOROUGH RESOLUTION 96-111

A RESOLUTION RECLASSIFYING FROM PRESERVATION TO COMMERCIAL APPROXIMATELY INVE ACRES OF BOROUGH LAND LOCATED IN COOPER LANDING IN THE QUARTZ CREEK AREA.

- WHEREAS, Ed and Kathleen Martin have submitted a petition to reclassify from Preservation to Commercial approximately 5 acres of borough land for development of a commercial tourist attraction, offering hands-on experience in gold mining and sluicing, etc., with small shops; and
- WHEREAS, the Kenai Peninsula Borough has received Final Decision from the State of Alaska for KPB municipal entitlement election ADL No. 201307, recorded in Book 470, Page 30, Kenai Recording District; and
- WHEREAS, in accordance with Chapter 17.10.080 public notice has been published and notification has been sent to land owners and/or leaseholders of record within a one-half mile radius of the land to be classified, applicable agencies, and interested parties; and
- WHEREAS, KPB Resolution 96-031 classified the subject land as Preservation with an overlay classification of Resource Management.
- WHEREAS, KPB Ordinance 96-37 incorporated the 1996 Cooper Landing Land Use Plan Update as an element of the Kenai Peninsula Borough Comprehensive Plan. KPB Resolution 96-079 classified Borough land in Cooper Landing as recommended by the 1996 Cooper Landing Land Use Plan Update.
- WHEREAS, the Planning Commission held a public hearing on the proposed classification during their regularly scheduled November 25, 1996 meeting. A motion to recommend adoption of the resolution failed unanimously.

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAY PENINSULA BOROUGH:

SECTION 1. The Borough land described as a portion of S¹/₂SW¹/₄ Section 20, and a portion of the N¹/₂NW¹/₄ Section 29, T5N, R2W, Seward Meridian, Alaska, lying west of Quartz Creek Road, containing 5 acres more or less be classified as Commercial.

SECTION 2. This classification shall take effect immediately upon adoption of this resolution.
