- WHEREAS, The school board submitted their budget to the Assembly on April 21, 1998 for approval of the total budget; and
- WHEREAS, the school district has requested additional local funding outside of the maximum local contribution determined through AS 14.17.025; and
- WHEREAS, within 30 days of receipt of the budget, the Assembly must determine the total amount of money to be made available from local sources for school purposes and must furnish to the school board a statement of the sum to be made available; and
- **WHEREAS**, the Assembly is required by law to appropriate the money for school purposes on or before June 30.

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Borough Assembly approves a total education budget for the fiscal year July 1, 1998 through June 30, 1999 as follows:
