SECTION 1. That the Mayor is authorized to award contracts to perform the work of the base bid for the following bid amounts:



SECTION 3. That the Mayor is authorized to execute all documents and make all agreements deemed necessary to complete these projects in accordance with this resolution and contract documents.


SECTION 4. That this resolution shall take effect immediately upon its adoption.
