**KENAI PENINSULA BOROUGH  
RESOLUTION 2001-050**

**A RESOLUTION REQUESTING THE ALASKA BOARD OF FISHERIES TO HOLD  
THE NEXT REGULARLY SCHEDULED UPPER COOK INLET AREA MEETING  
CONCERNING ALL FINFISH IN THE KENAI/SOLDOTNA AREA**

- WHEREAS,** the Alaska Board of Fisheries conducts one regularly-scheduled meeting every three years addressing Upper Cook Inlet Area finfish, with the next such meeting scheduled to be held during the 2001-2002 winter; and
- WHEREAS,** the Upper Cook Inlet area includes that area of Cook Inlet lying north of a line extending from Anchor Point due west to a point just north of Chinitna Point; and
- WHEREAS,** the majority of Upper Cook Inlet finfish proposals considered by the Board of Fisheries pertain to the Kenai, Kasilof and other Central District Salmon runs and the commercial, sports and personal use fisheries dependent upon these runs; and
- WHEREAS,** the Board of Fisheries conducted their last meeting here on the Peninsula concerning Upper Cook Inlet finfish, which is the area primarily affected by the Board's deliberations; and
- WHEREAS,** the Kenai/Soldotna area has ample accommodations to support such Board of Fisheries meetings; and
- WHEREAS,** many people significantly affected by the Board of Fisheries actions relating to the Upper Cook Inlet are unable to attend the meetings in Anchorage due to a lack of time and funds; and
- WHEREAS,** it would be beneficial for the Board of Fisheries members to hear from such members of the public, and to view the rivers and the infrastructure created by the finfish fisheries;
- WHEREAS,** the Alaska Board of Fisheries will set the location for Upper Cook Inlet Area finfish meetings at the May, 2001 meeting;


**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

- SECTION 1.** That the Kenai Peninsula Borough Assembly requests the Board of Fisheries hold the next regularly scheduled or any unscheduled Upper Cook Inlet Area meetings concerning all finfish in the Kenai/Soldotna area.


