**KENAI PENINSULA BOROUGH  
RESOLUTION 2001- 057**

**A RESOLUTION AUTHORIZING THE MAYOR TO DEVELOP A GRAVEL SOURCE ON BOROUGH LAND LOCATED WITHIN THE NE1/4, EXCLUDING E1/2 NE1/4 NE1/4, SECTION 22, T8N, R11W, S.M., ALASKA, ALSO KNOWN AS ASSESSOR PARCEL NO. 013-020-13 FOR THE PURPOSE OF PROVIDING GRAVEL FOR THE NORTH ROAD EXTENSION PROJECT SUBJECT TO CONDITIONS**

**WHEREAS**, the borough supports the North Road Extension project as evidenced by its application and receipt of a TEA-21 grant of approximately \$6 million from the federal government; and

**WHEREAS**, the grant requires a 20 percent match from the borough that may be in kind including gravel used for construction of the road; and

**WHEREAS**, the borough desires that the TEA-21 grant be used in a manner that will extend the Kenai Spur Highway the greatest distance possible; and

**WHEREAS**, gravel is a significant cost item in the extension of the Kenai Spur Highway; and

**WHEREAS**, the borough has confirmed a substantial gravel source on its land; and

**WHEREAS**, Resolution 2001-056 classifies subject borough land residential with resource management overlay; and

**WHEREAS**, the highest and best use of the land is to remove the gravel resource and then reclaim the land for residential development; and

**WHEREAS**, at its May 14, 2001 meeting, the Planning Commission recommended adoption of this resolution;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** The assembly authorizes the mayor to develop the gravel source located within the NE1/4, excluding E1/2 NE1/4 NE1/4, Section 22, T8N, R11W, S.M., Alaska, also known as Assessor Parcel No. 013-020-13, for the purpose of using the gravel for the construction of the North Road Extension.

**SECTION 2.** Prior to the expenditure of funds for this project, the assembly must approve by resolution a plan for development of the material site.


**SECTION 3.** Prior to development of the site described in Section 1, the mayor shall also investigate other potential material sites in the Nikiski area as the mayor deems practical and shall make a recommendation to the assembly concerning the use of gravel sources for the North Road Extension project.

**SECTION 4.** This resolution takes effect immediately upon its adoption.
