RESOLUTION 2001-114**

**A RESOLUTION ENDORSING SPECIFIC PROJECTS BY THE STATE OF ALASKA
DEPARTMENT OF TRANSPORTATION/PUBLIC FACILITIES FOR THE 2004-2006
STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM (STIP)**

WHEREAS, the 2004-2006 STIP process has begun and the Department of Transportation and Public Facilities (DOT/PF) is accepting nominations for submitting projects; and

WHEREAS, nominations and supplemental project information were due by October 3, 2001; and

WHEREAS, if a project is unchanged from the 2001-2003 nomination effort, no new project nomination is required; and

WHEREAS, the STIP is directed at the federal highway program; and

WHEREAS, DOT/PF representatives have advised the Kenai Peninsula Borough Assembly that it will consider a resolution endorsing projects that were submitted to DOT/PF by the October 3, 2001 deadline;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI
PENINSULA BOROUGH:**

SECTION 1. That the borough priorities shown in Attachment A entitled Kenai Peninsula Borough 2004-2006 STIP Priorities, incorporated herein by reference, are hereby established as priorities for the Kenai Peninsula Borough for inclusion in the 2004-2006 federal fiscal year STIP list.

SECTION 2. That the Assembly finds that the major purpose of the projects listed in Attachment A is to extend the life of an existing facility by 10 or more years. In addition, the projects would support and constitute an economic development project, provide a significant contribution to improved health or quality of life, or would greatly improve connectivity between modes and coordination and integration of passenger and freight systems and services.

SECTION 3. That projects 7, 8, and 10, listed in Attachment A will provide new or improved access to two or more uses including water sources, landfills, sewer lagoons/honey bucket sites, healthcare, airports, subsistence sites or river/ocean access.

SECTION 4. That a copy of this resolution and the attachments shall be provided to Governor Tony Knowles, Senator John Torgerson, Senator Jerry Ward, Senator Georgianna Lincoln, Representative Mike Chenault, Representative Ken Lancaster, Representative Drew Scalzi, Representative Carl Morgan, and Department of Transportation/Public Facilities Commissioner Joseph L. Perkins, P.E.,

SECTION 5. That this resolution becomes effective immediately upon its adoption.

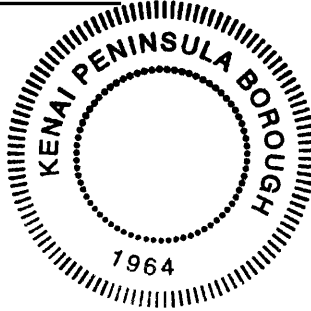
