KENAI PENINSULA BOROUGH RESOLUTION 2002-069

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF LATE-FILED SENIOR CITIZEN EXEMPTION APPLICATIONS

- **WHEREAS,** the borough has received three requests that the borough accept late-filed applications for the senior citizen residential real property exemption; and
- **WHEREAS,** under Alaska Statute 29.45.030(f) the governing body for good cause shown may waive a claimant's failure to make timely application for an exemption for that year; and
- WHEREAS, the application filed by Mr. Jack C. Murray for parcel No. 015-210-13 was submitted January 11, 2002, requesting that the borough accept his late-filed application for the 2001 senior citizen exemption; and
- WHEREAS, Mr. Murray failed to provide the application in a timely manner because he was in the hospital, and the person who was to take care of his paperwork failed to do so; and
- WHEREAS, the application filed by Carolyn Cerney for parcel No. 039-102-32 requested the assembly waive her late-filed exemption application for 2001 and 2002 for the reason that she has been experiencing memory problems and requires assisted living services; her children just learned that the application had not been filed for these years; and she has qualified since 1998 for this exemption and immediately filed the request to accept a late-filed application; and
- WHEREAS, Gregory R. Gabriel filed a request to accept a late-filed application for parcel No. 131-250-45 on the grounds that Mrs. Gabriel provided the necessary documentation with the assessing department prior to the January 15, 2001 deadline; the person who accepted the documentation advised her she was a part-time worker and was not sure what to do but that she would pass it on to her supervisor; and the assessing department has since not been able to locate this application; and
- **WHEREAS,** the assembly finds good cause for waiving the deadline for filing the 2001 and 2002 senior exemption applications, as applicable, for the above described three applicants;

SECTION 1. That the deadline for filing 2001 and 2002 applications, as applicable, for senior citizen real property exemption for the following parcels is hereby waived for good cause:

Jack C. Murray	-	parcel no. 015-210-13
Caroline Cerney	-	parcel no. 039-102-32
Gregory R. Gabriel	-	parcel no. 131-250-45

SECTION 2. That the assessor shall process the applications as filed in accordance with standard assessing department procedures for processing such applications.

SECTION 3. That this resolution shall take effect immediately upon its enactment.
