A RESOLUTION AUTHORIZING THE ACCEPTANCE OF LATE-FILED SENIOR CITIZEN EXEMPTION APPLICATIONS

- WHEREAS, the application filed by Velma Baier for parcel No. 012-040-31 and 012-040-32 was submitted May 16, 2002, requesting that the borough accept her late-filed application for the 2002 senior citizen exemption due to a critical illness with her sister and open heart surgery for her son; and
- WHEREAS, the application filed by Robert L. Clay for parcel No. 059-380-23 was submitted May 22, 2002, requesting the borough accept his late-filed application for the 2002 senior citizen exemption for the reason that he was out of the State; and
- WHEREAS, the application filed by John W. Duncan for parcel No. 047-021-53 was submitted January 17, 2002, requesting the borough accept his late-filed application for the 2002 senior citizen exemption for the reason that he was not aware of the deadline for filing; and
- WHEREAS, the application filed by Donald A. Eide for parcel No. 043-050-04 was submitted May 20, 2002, requesting the borough accept his late-filed application for the 2002 senior citizen exemption for the reason that he was attending a family emergency outside the State; and
