
SECTION 19. That in the South Peninsula Hospital Service Area, the following were elected to 1-year terms, having received the greatest number of votes cast:

SECTION 21. That in the South Peninsula Hospital Service Area, Seat G, Colleen M. Behen was elected to a 2-year term, having received the greatest number of votes cast.


- SECTION 22.** That because of the defeat of the proposition establishing the Anchor Point Port and Harbor Service Area, no board members were elected.
- SECTION 23.** That Proposition No. 1, regarding the districting for the Kenai Peninsula Board of Education, the voters of the borough chose 9 single member districts elected by district.
- SECTION 24.** That Proposition No. 2, authorizing the sale of bonds for improvements to the regional solid waste facility near Soldotna, was approved by the voters of the borough.
- SECTION 25.** That Proposition No. 3, issuing up to \$14,700,000 in general obligation bonds for construction of a new middle school in Seward, was approved by the voters of the borough.
- SECTION 26.** That Proposition No. 4, regarding the initiative to exempt all sales of nonprepared food items from borough sales tax, was defeated by the voters of the borough.
- SECTION 27.** That Proposition No. 5, establishing a service area to exercise the powers necessary to provide a port and harbor feasibility study, was defeated by the voters in the Anchor Point Service Area.
- SECTION 28.** That this resolution takes effect immediately upon its adoption.
