**KENAI PENINSULA BOROUGH  
RESOLUTION 2004-010**

**A RESOLUTION SUPPORTING AND RECOGNIZING THE SIGNIFICANCE OF  
COASTAL PLANNING AND SUPPORTING THE ROLES OF THE KENAI  
PENINSULA BOROUGH COASTAL DISTRICT AND THE ALASKA COASTAL  
DISTRICT ASSOCIATION IN THE ALASKA COASTAL MANAGEMENT PROGRAM**

**WHEREAS,** the Kenai Peninsula Borough elected to participate in the State of Alaska Coastal Management Program and adopted the Kenai Peninsula Borough Coastal Management Program in Ordinance 90-20, which provides representation of local interests in state and federal permitting decisions; and

**WHEREAS,** the Kenai Peninsula Borough has made a clear statement of support of the Borough's policies, expressed in the borough's coastal management program; and

**WHEREAS,** the Kenai Peninsula Borough is recognized as one of thirty-five coastal districts with common interest in the regulation of development activities occurring in the coastal zone boundary;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** The Kenai Peninsula Borough recognizes the significance of coastal planning and supports the roles of the Kenai Peninsula Borough Coastal District and of the Alaska Coastal District Association.

**SECTION 2.** The Kenai Peninsula Borough supports the efforts of the Alaska Coastal District Association by recognizing the Kenai Peninsula Borough Coastal District Coordinator as the Borough's representative in that organization.


**SECTION 3.** The Kenai Peninsula Borough requests that new state statutes and regulations pertaining to the Alaska Coastal Management Program not reduce local government's role in that state program; and

**SECTION 4.** The Kenai Peninsula Borough requests legislative relief for meeting the deadlines for borough policy changes as presently required in HB 191 and supporting regulations.


