**AUTHORIZING AWARD OF CONTRACTS FOR ONE (1) GROUP A AND FIVE (5),
 GROUP B ROAD CAPITAL IMPROVEMENT PROJECTS**

WHEREAS, the Kenai Peninsula Borough has solicited and received bids for these projects;
 and

WHEREAS, the low responsive bid on each project is fair and reasonable, and the bidders are
 qualified to perform the work; and

WHEREAS, one project from Group A (Upper Greer Road/ Tracy Avenue) needed additional
 funds to be awarded; and

WHEREAS, the additional funds necessary to award Upper Greer Road/Tracy Avenue were
 appropriated by Ordinance 2003-19-58, passed by the assembly on July 6, 2004;
 and

WHEREAS, funds are available in the Road Service Area capital improvement budget for
 these projects;

 following bid amounts:



SECTION 3. That the mayor is authorized to execute all documents and make all agreements deemed necessary to complete these projects in accordance with this resolution and contract documents.


