**KENAI PENINSULA BOROUGH
RESOLUTION 2005-055**

APPROVING THE CONSTRUCTION OF LACROSS WAY LOCATED IN THE ROAD SERVICE AREA WEST REGION, UNIT 2, PURSUANT TO KPB 16.41.190

WHEREAS, the residents of the Kenai Peninsula Borough Road Service Area (“RSA”) approved construction powers by popular vote at the regular election in October 2000; and

WHEREAS, KPB 16.41.190 requires the RSA Board to apply criteria set forth in that section in making recommendations to the assembly regarding road construction projects; and

WHEREAS, at its May 10, 2005, meeting, the RSA applied the criteria set forth in KPB 16.41.190 and recommended construction of LaCross Way in the West Region, Unit 2; and

WHEREAS, RSA Board Resolution 2005-04 and Memorandum dated May 10, 2005 have been forwarded to the assembly for its consideration;


NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the assembly adopts the findings and recommendations of the Road Service Area Board contained in the Road Service Area Resolution 2005-04.

SECTION 2. That the assembly hereby approves construction of LaCross Way pursuant to KPB 16.41.190.


SECTION 3. That this resolution takes effect immediately upon its adoption.

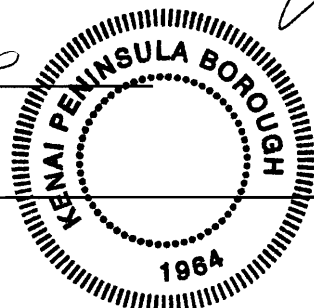

**KENAI PENINSULA BOROUGH ROAD SERVICE AREA
RESOLUTION 2005 - 04**

**A RESOLUTION RECOMMENDING THAT THE KENAI PENINSULA
BOROUGH ASSEMBLY APPROVE THE CONSTRUCTION OF THE
RELOCATION OF LACROSS WAY**

WHEREAS, the residents of the Kenai Peninsula Borough Road Service Area (RSA) approved construction powers by popular vote at the regular election in October 2000; and

WHEREAS, KPB16.41.190 provides that the board shall make an annual report and recommendation to the assembly regarding any construction projects to be the undertaken considering the criteria set forth in the code; and

WHEREAS, LaCross Way is on our road maintenance system in West Region, Unit 2, at approximately Mile 101 Sterling Highway; and

WHEREAS, this road is safety problem due to a steep grade approaching the Sterling Highway and the site distance problem when entering the Sterling Highway, as well as the general substandard condition of the road; and

WHEREAS, the majority property owner in the subdivision has agreed to replat the area to allow for the relocation of this road to alleviate these safety concerns; and

WHEREAS, the RSA board was notified of this proposed project at the April 2005 meeting;

NOW, THEREFORE, BE IT RESOLVED BY THE ROAD SERVICE AREA BOARD:

SECTION 1. Based on the standards set forth in the code, the RSA board makes the following findings in recommending construction of LaCross Way to the KPB Assembly:

STANDARD: Whether there is available road service area funding.

FINDING: There is \$755,955 recommended in the FY2006 RSA budget. LaCross Way is scheduled to be one of the FY2006 capital improvement projects included in this funding.

STANDARD: Whether the road access public lands or facilities.

FINDING: No. The code does not require all of the criteria to be observed.

STANDARD: Whether the road is a collector road.

FINDING: No. This road is the only access to a 29-parcel subdivision, and an adjoining undeveloped 20-acre parcel.

STANDARD: Whether there are funding sources in addition to RSA funds.
FINDING: No. This CIP is intended to be part of the FY06 CIP funds.

STANDARD: Whether the construction will provide an improved alternate route to a road currently certified for maintenance.

FINDING: The new proposed road will not provide an alternate access but will eliminate the danger caused by the sloped approach to the highway and the site-distance problem when entering the highway.

SECTION 2. The RSA board recommends construction of the relocation of LaCross Way to the borough assembly based on the above findings and attached memorandum incorporated by reference as if fully set forth herein.


SECTION 3. A copy of this resolution shall be forwarded to the mayor and the assembly.
