The total bid consists of providing all labor, materials, equipment and tools to resurface 3 interior walls (following an asbestos abatement project by Borough personnel) as indicated in the contract documents (wall area is approximately 2,850 square feet) and furnish and install sound-dampening wall panels as indicated in the contract documents.
