KENAI PENINSULA BOROUGH RESOLUTION 2005-093

A RESOLUTION AUTHORIZING THE SOLE SOURCE PURCHASE OF A VARIETY OF SPECIALTY MEDICAL EQUIPMENT TOTALING \$837,000 FOR THE CENTRAL PENINSULA GENERAL HOSPITAL EXPANSION PROJECT

- WHEREAS, funding for the hospital expansion and outfitting of the necessary medical equipment was established per Ordinance 2003-27 and through the passage of Bond Proposition No. 2 in the October 2003 regular election, and certified by Resolution 2003-111 on October 14, 2003; and
- WHEREAS, the project's Architectural and Equipment design consultants, in cooperation with the medical staff within CPGH Inc., have evaluated the product lines of multiple manufacturers; and
- WHEREAS, based on the completion of an extensive evaluation process, the design team and CPGH Inc. have determined that medical equipment manufacturers Hill-Rom, Steris, Berchtold, Cenorin/HLD, SpaceSaver and Arjo, which are the leading manufactures in each specific medical equipment field, offer the best overall solution for the project needs; and
- WHEREAS, the CPGH staff, having consistently used these brands of equipment, are familiar with and are trained on these products and maintain service contracts that can be extended to these chosen manufactured items; and
- WHEREAS, the KPB has requested quotes from the above-stated manufacturers for the various specialty medical equipment as contained in the attached list and have determined that the cost of the equipment totaling up to \$837,000 is within budget; and
- WHEREAS, the KPB finds that the acquisition and installation of the new specialty medical equipment is in the best interest of the Borough and in furtherance of the public purposes of the Borough's hospital project; and
- WHEREAS, the KPB finds that the sole source purchase of the specialty medical equipment will be used for an essential public health function;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the Mayor or his designee is authorized to negotiate, and the mayor is authorized to execute, a sole source purchase of specialty medical equipment as shown on the attached list for the CPGH Expansion Project, for a capital cost not to exceed \$837,000.
- SECTION 2. That expenditures in the amount of \$837,000 will be charged to account No. 401.81111.04CHB.48516 (hospital equipment).

SECTION 3. That this resolution takes effect immediately upon its adoption.
