

BY-LAWS FOR OPERATION OF THE
KENAI PENINSULA ROAD SERVICE AREA BOARD

Section 1. The Road Service Area Board shall set rules of procedure for the conduct of its meetings.

Section 2. That these rules are procedural and are not in conflict with rules and regulations governing the operation of the road service area board as established and adopted in Exhibit "A" to Resolution 92- 26.

Section 3. That attendance and participation at meetings by members of the public or by members of the board may be by teleconferencing. The vote taken at a meeting held by teleconference shall be taken by roll call.

4. Approval of Minutes
5. Correspondence
6. Public Presentation with Prior Notice
7. Public Presentation without Prior Notice
8. Road Manager's Report
9. Other

11. Adjournment

WHEREAS, KPB 16.41.150 requires that bylaws be established by the Road Service Area Board in order to conduct its meetings; and


WHEREAS, such bylaws must be approved by the assembly by resolution; and

WHEREAS, on February 10, 1992, the road service area board adopted new bylaws;


NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. That the bylaws of the Kenai Peninsula Road Service Area, to set rules of procedure for the conduct of its meetings adopted by the road service area board on February 10, 1992 and attached as Exhibit A, and hereby incorporated as part of this resolution by reference are hereby adopted pursuant to KPB 16.41.150 to govern the operation of the road service area.
- Section 2. That such bylaws as approved will continue in effect until changed in accordance with the ordinances of the Kenai Peninsula Borough governing the Kenai Peninsula Borough Road Service Area.
- Section 3. That all earlier bylaws of the Kenai Peninsula Borough Road Service Area, including the former East, Central, North & South Kenai Peninsula Borough Road Maintenance Service Areas, are hereby rescinded with adoption of this resolution.
- Section 4. That this resolution takes effect immediately upon its adoption.
