
NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 4.** That in Assembly District 8, Bill Smith was re-elected to a 3-year term, having received the greatest number of votes cast.

- SECTION 19.** That Proposition No. 1, Seasonal Sales Tax Exemption on Nonprepared Food Items, was approved by the voters of the borough.


SECTION 20. That this resolution takes effect immediately upon its adoption.
