**SECTION 5.** That in Board of Education District 6, Lynn Hohl was re-elected to a 3-year term, having received the greatest number of votes cast.



Seat G – Jane M. Stein for a 3-year term



Seat E – Martin K. “Marty” Hall for a 1-year term

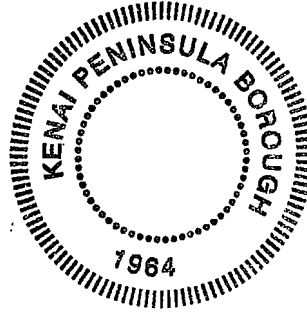
