- **SECTION 21.** That Proposition No. 4, abolishing the Lowell Point Emergency Service Area, was ratified by the voters of the service area.
- **SECTION 22.** That Proposition No. 5, establishing the Seldovia Recreational Service Area, was ratified by the voters of the service area.

SECTION 23. That this resolution takes effect immediately upon its adoption.
