**KENAI PENINSULA BOROUGH  
ORDINANCE 2000-15**

**AN ORDINANCE APPROVING THE REMODEL OF CENTRAL PENINSULA  
HOSPITAL BATHROOM FACILITIES AND APPROPRIATING \$300,000 FROM THE  
HOSPITAL PLANT EXPANSION AND REPLACEMENT FUND FOR THE PROJECT**

- WHEREAS,** the bathrooms in the Central Peninsula Hospital Medical/Surgical Department are currently inadequate to meet the needs of the patients using the facility to the extent that it is potentially necessary for up to four patients to share a single bathroom; and
- WHEREAS,** the current bathrooms are not handicap accessible and do not comply with the Americans with Disabilities Act (ADA) Code; and
- WHEREAS,** the current bathrooms have caused an infection control issue and a standard of care that is not typically seen in today's health care setting; and
- WHEREAS,** a bathroom remodel project consisting of the addition of eight new bathrooms with an option for eight showers to the 1972 portion of the Medical/Surgical Department will adequately address current use, access and health issues; and
- WHEREAS,** the cost of completing the project is estimated at \$300,000; and
- WHEREAS,** funds are available in the Central Peninsula Hospital Plant Expansion and Replacement Fund to complete the project; and
- WHEREAS,** pursuant to paragraphs 12 c. and 13 b. of the Lease and Operating Agreement with CPGH, Inc., borough assembly approval is required for all capital improvement projects costing more than \$100,000; and
- WHEREAS,** the Central Peninsula Hospital Service Area Board approved the project at its February 16, 2000 board meeting; and


**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the assembly approves a Central Peninsula Hospital Bathroom Remodel Project consisting of the addition of eight bathrooms with an option for eight showers to the 1972 portion of the Medical/Surgical Department.


**SECTION 2.** That \$300,000 is appropriated from the Central Peninsula Hospital Plant Expansion and Replacement Fund to the Central Peninsula Hospital Capital Improvement Fund account number 600.81111.00BTH.49999 for this project.

**SECTION 3.** That this ordinance takes effect immediately upon enactment.
