## KENAI PENINSULA BOROUGH ORDINANCE 2000-20

## AN ORDINANCE APPROPRIATING \$451,245.48 FROM THE DIVISION OF EMERGENCY SERVICES TO REIMBURSE THE BOROUGH FOR COST INCURRED IN RESPONDING TO THE SEVERE WINTER STORMS OCCURRING FROM DECEMBER 21, 1999 TO FEBRUARY 23, 2000.

- WHEREAS, the Borough was hit by a number of winter storms between the dates of December 21, 1999 to February 23, 2000; and
- WHEREAS, the Borough incurred substantial costs due to these winter storms; and
- WHEREAS, the Road Service Area provided emergency access for Borough citizens and the protection of improved properties and access to Borough designated emergency shelters; and
- WHEREAS, the Central Emergency Service Area provided assistance in locating a musher lost during the Tustumena 200 Sled Dog Race; and
- WHEREAS, the Maintenance Department provided access to Borough designated emergency shelters and reduced snow loads from Borough facilities which prevented further damage; and
- WHEREAS, the Bear Creek Fire Service Area incurred substantial costs in maintaining access to their facilities; and
- **WHEREAS,** the Kenai Peninsula Borough general government incurred administrative costs in requesting, obtaining, and administering federal disaster assistance; and
- WHEREAS, a disaster was declared by the Borough Mayor on February 3, 2000, by the State of Alaska on February 4, 2000 and amended on February 8, 2000 to include the Kenai Peninsula Borough and signed by the President on February 17, 2000;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That \$288,974.00 in costs incurred by the Road Service Area in response to these storms be appropriated to the Disaster Relief Fund and to the Road Service Area Fund. An intergovernmental charge from the Road Service Area will be made to the Disaster Relief Fund to transfer these costs.
- **SECTION 2.** That \$8,461.38 in costs incurred by the Central Emergency Service Area in response to these storms be appropriated in the Disaster Relief Fund and to the Central Emergency Service Area Fund. An intergovernmental charge from the Central Emergency Service Area will be made to the Disaster Relief Fund to transfer these costs.
- **SECTION 3.** That \$141,490.80 in costs incurred by the Maintenance Special Revenue Fund in response to these storms is appropriated to the Disaster Relief Fund and to the Maintenance Special Revenue Fund. An intergovernmental charge from the Maintenance Special Revenue Fund will be made to the Disaster Relief Fund to transfer these costs.
- **SECTION 4.** That \$2,490.95 in costs incurred by the Bear Creek Service Area in response to these storms is appropriated to the Disaster Relief Fund and to the Bear Creek Service Area Fund. An intergovernmental charge from the Bear Creek Service Area will be made to the Disaster Relief Fund to transfer these costs.
- **SECTION 5.** That \$9,828.35 in costs incurred by the General Fund in response to these storms is appropriated to the Disaster Relief Fund and to the General Fund. An intergovernmental charge from the General Fund will be made to the Disaster Relief Fund to transfer these costs.
- **SECTION 5.** That this ordinance takes effect immediately upon its enactment.
