- Resale Certificates are processed each Thursday. Applications received after 12:00 P.M. on Tuesday will not be processed until the following week.
- Original application must be submitted. Cost per Resale Certificate is \$10.00 per certificate issued.
- Resale Certificates will NOT be issued if account is not in compliance with KPB Code 5.18.
- ORIGINAL RESALE CERTIFICATE MUST BE PRESENTED TO THE SELLER AT THE TIME OF PURCHASE IN ORDER TO RECEIVE THE EXEMPTION, NO COPIES.
